WHAT DOES SIGNATURE ESTATE & INVESTMENT ADVISORS, LLC (“SEIA”) DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Assets and account balances
- Investment experience and risk tolerance

When you are *no longer* our client, we continue to share your information as described in this notice.

How?

All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons SEIA chooses to share; and whether you can limit this sharing.

What we do

How does SEIA protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does SEIA collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none">■ Open an account or enter into an investment advisory agreement■ Give us your income information and your contact information■ Tell us about your investment or retirement portfolio We also collect your personal information from other companies
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none">■ sharing for affiliates' everyday business purposes—information about your creditworthiness■ affiliates from using your information to market to you■ sharing for non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account—unless you tell us otherwise.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none">■ <i>Our affiliates include companies with a Signature name; financial companies such as Signature Estate Securities; nonfinancial companies, such as Signature Estate & Insurance Services</i>
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none">■ <i>SEIA does share with non-affiliates for marketing purposes. For example, when a departing advisor takes non-custodial referral client data.</i>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none">■ <i>SEIA doesn't jointly market</i>

Other Important information

Information for Vermont, California and Nevada Customers

California, North Dakota and Vermont residents: In response to applicable state law, if the mailing address provided for your account is in California, North Dakota, or Vermont, we will automatically treat your account as if you do not want us to disclose your personal information to non-affiliated third parties for purposes of them marketing to you, except as permitted by the applicable state law. Nevada residents: Nevada law requires us to disclose that you may request to be placed on our “do not call” list at any time by calling us at 800.426.5105. Rights under the California Consumer Privacy Act: (i) If you are a California Resident you have the right to:

1. Request we disclose to you free of charge the following information covering the 12 months preceding your request: a. the categories of Personal Information about you that we collected; b. the categories of sources from which the Personal Information was collected; c. the purpose for collecting Personal Information about you; d. the categories of third parties to whom we disclosed Personal Information about you and the categories of Personal Information that was disclosed (if applicable) and the purpose for disclosing the Personal Information about you; and e. the specific pieces of Personal Information we collected about you;
2. Request we delete Personal Information we collected from you, unless the CCPA recognizes an exception; and
3. Be free from unlawful discrimination for exercising your rights under the CCPA.
